## BE Semiconductor Industries Announces Transactions Under Share Repurchase Program

Duiven, the Netherlands, April 25, 2016 - BE Semiconductor Industries N.V. (the "Company" or "Besi") (Euronext Amsterdam: BESI; OTC markets: BESIY, Nasdaq International Designation), a leading manufacturer of assembly equipment for the semiconductor industry, today announced that it repurchased 24,500 of its ordinary shares during the period from Friday April 15, 2016 up to and including Monday April 25, 2016 at a weighted average price of € 24.47 for a total purchase amount of € 599,627. Since September 25, 2015, Besi has purchased a total of 554,831 of its ordinary shares at a weighted average price of € 19.23 for a total purchase amount of € 10,666,602. The share repurchases are part of a buy-back program announced on September 25, 2015.
