BE Semiconductor Industries Announces Transactions Under Share Repurchase Program

Duiven, the Netherlands, August 24, 2016 - BE Semiconductor Industries N.V. (the "Company" or "Besì") (Euronext Amsterdam: BESI; OTC: BESIY - Nasdaq International Designation), a leading manufacturer of assembly equipment for the semiconductor industry, today announced that it repurchased 24,500 of its ordinary shares during the period from Tuesday August 16, 2016 up to and including Wednesday August 24, 2016 at a weighted average price of € 27.44 for a total purchase amount of € 672,341. Since September 25, 2015, Besì has purchased a total of 859,331 of its ordinary shares at a weighted average price of € 21.33 for a total purchase amount of € 18,325,503. The share repurchases are part of a buy-back program announced on September 25, 2015.
