DOCdata acquires Contributie Services B.V.

DOCdata N.V. today announces that Triple Deal B.V., a majority-owned subsidiary of DOCdata, has bought all issued shares of Contributie Services B.V. in Utrecht from Conclusion B.V., who founded the company.

With the acquisition of Contributie Services B.V., DOCdata has taken the next step in repositioning the company that is listed at Euronext Amsterdam. Michiel Alting von Geusau, CEO of DOCdata N.V.: "More and more organisations come to appreciate the commercial opportunities the Internet is offering them. The know-how to transfer these opportunities into specific projects is available in the market, however only in a very fragmented way. Building a web shop, warehousing, shipping orders, electronic payments, return handling; they are all completely interdependent. Who is able to interconnect them, is successful.
