## **ForFarmers: update on share buy-back programme of its own shares**

**ForFarmers N.V. (hereinafter 'ForFarmers') has repurchased 87,750 shares in the period from 21 August 2017 through 25 August 2017.**

The shares were repurchased for an average price of €10.23 per share, for a total amount of €897,373. These repurchases were made in accordance with the authorisation granted by the ForFarmers N.V. Annual General Meeting of Shareholders on 26 April 2017 as part of the share buy-back programme announced on 2 May 2017.

The total number of shares that has been repurchased to date according to this programme is 4,256,434 shares, for a total amount of €41,094,822.
