Progress on Just Eat Takeaway.com share buyback programme 22 January – 26 January 2024

Just Eat Takeaway.com N.V. (LSE: JET, AMS: TKWY), hereinafter the “Company”, or together with its group companies “Just Eat Takeaway.com”, one of the world’s largest online food delivery marketplaces, hereby reports the transaction details related to its €150 million share buyback programme announced on 18 October 2023.

During the week of 22 January 2024 up to and including 26 January 2024 a total of 179,146 shares were repurchased at an average price of €13.9463 on Euronext Amsterdam. Following the settlement of the above transactions, the Company will hold 15,007,036 shares in treasury.

Up to and including 26 January 2024, the total consideration for shares repurchased under this share buyback programme amounts to €59,165,257.
