Progress on Just Eat Takeaway.com share buyback programme 9 December – 13 December 2024

Just Eat Takeaway.com N.V. (LSE: JET, AMS: TKWY), hereinafter the “Company”, or together with its group companies “Just Eat Takeaway.com”, one of the world’s largest online food delivery marketplaces, hereby reports the transaction details related to its €150 million share buyback programme announced on 31 July 2024.

From 9 December 2024 up to and including 13 December 2024 a total of 285,915 shares were repurchased at an average price of €15.8051 on Euronext Amsterdam. Following the settlement of the above transactions, the Company will hold 6,378,737 shares in treasury.

Up to and including 13 December 2024, the total consideration for shares repurchased under this share buyback programme amounts to €85,583,004.
