Annual General Meeting of Shareholders of OCI N.V.

OCI N.V. (NYSE Euronext: OCI)) invites shareholders to the Annual General Meeting of Shareholders (AGM) to be held on Wednesday 10 June 2015 at 15:00 CET at Hotel De l'Europe, Nieuwe Doelenstraat 2-14, 1012 CP Amsterdam, the Netherlands.

Voting items are:

- a) Proposal to adopt the Annual Accounts 2014;
- b) Proposal to allocate the profits over the 2014 financial year to the reserves;
- c) Proposal to discharge the Executive Directors from liability;
- d) Proposal to discharge the Non-Executive Directors from liability;
- e) Proposal to appoint Mr. G. Heckman as Non-Executive Director;
- f) Proposal to reappoint Mr. M. Bennett as Non-Executive Director;
- g) Proposal to reappoint Mr. J. Ter Wisch as Non-Executive Director;
- h) Proposal to adjust the Remuneration Policy;
- i) Proposal to appoint KPMG as auditor charged with the auditing of the Annual Accounts for the 2015 financial year;
- i) Proposal to increase the issued share capital and to amend the articles of association of the Company;
- k) Proposal to designate the Board of Directors as the authorised body to issue shares in the share capital of the Company;
- l) Proposal to designate the Board of Directors as the authorised body to restrict or exclude pre-emptive rights upon the issuance of shares; and
- m) Proposal to authorise the Board of Directors to repurchase shares in the share capital of the Company.
