## Ordina nominates Caroline Princen as Supervisory Board member

At the recommendation of the Stichting Prioriteit Ordina Groep, Ordina's Supervisory Board intends to ask the General Meeting of Shareholders on 26 April 2018 to approve the appointment of Caroline Princen as a member of the Ordina N.V. The Supervisory Board will be pleased to propose her appointment to the General Meeting on 26 April 2018."
