TKH strengthens position in industrial camera solutions

TKH announces that it has reached agreement on the expansion of its 30% minority stake in New Electronic Technology (NET) GmbH in Germany to a majority stake of 84%. NET provides high-grade camera systems for solutions in the industrial, medical and research sectors and is market leader in Germany in the segments in which it operates.

TKH holds its minority stake in NET since 2004. With the expansion of this stake, the TKH group's portfolio for camera systems gets a boost. NET's know-how can be deployed effectively in the expansion of the activities in the security segment – which TKH has identified as a growth segment. The technology developed and deployed by NET is distinctive due to its innovative camera solutions and high-quality image transmission, combined with software to analyse images.

NET realises more than 57% of its turnover in Germany. In addition to the main operation in Germany, NET also has operations in the United States and Japan. NET has 28 employees (FTEs) and realises annual turnover of around € 17 million.

The acquisition of NET will make a positive contribution to TKH's earnings per share as from the second half of 2007. NET will become part of the Industrial Solutions segment within the Technical Trading group of TKH. The acquisition will be financed from available resources.
