



TomTom share buyback periodic update, 26 – 30 April 2021

Amsterdam, The Netherlands, 04 May 2021, 07:30 CEST - TomTom ([TOM2](#)), today announced that it has repurchased 218,563 ordinary TomTom shares at an average price of €7.74 per share in the period from 26 April 2021 up to and including 30 April 2021. The aggregate consideration of this repurchase was €1.7 million. These repurchases were made as part of the company's €50 million share buyback program initially [announced](#) on 2 March 2020 and [resumed](#) on 15 February 2021.

The total number of shares repurchased since the initial announcement of the program up to and including 30 April 2021 is 5,578,272 shares for a total aggregate consideration of €42.0 million.

TomTom will use the shares to cover its commitments arising from its long-term employee incentive plans. Details of the share buyback transactions can be found on the company's [website](#).
