Van Lanschot Kempen announces EGM on capital return proposal

Amsterdam/'s-Hertogenbosch, the Netherlands, 27 February 2025

On 10 April 2025, Van Lanschot Kempen will hold an extraordinary general meeting (EGM) to decide on its proposal to return capital in the amount of €1.40 per Class A share in issue. This proposal was announced on the day of the release of Van Lanschot Kempen's 2024 full-year results on 27 February 2025. De Nederlandsche Bank (DNB) has approved the capital return.

If shareholders agree to the capital return, payment will, in principle, take place in June 2025. This will be charged to the proportion of the share premium reserve available for distribution, and the total share capital in issue will be unchanged. After the capital return, the CET 1 ratio according to the "Basel IV fully loaded" definitionⁱ will remain ahead of Van Lanschot Kempen's target of 17.5%.

This target was shared at the Investor Day on 20 June 2024, when Van Lanschot Kempen also shared its intention to return additional capital to shareholders above a CET 1 ratio of 17.5% according to the "Basel IV fully loaded" definitionⁱ. At that time, excess capital stood at approximately €45 million. The amount of excess capital has increased since and, through the now proposed return, Van Lanschot Kempen will be returning approximately €59 million.

The capital return proposal and resolutions to amend the Articles of Association to effect the return will be put to a vote at the EGM scheduled to take place in 's-Hertogenbosch, the Netherlands, on 10 April 2025 at 11.00 am CET.
