Arjan Huisman to step down as a member of the Management Board of Van Lanschot Kempen in May 2026

Van Lanschot Kempen today announced that Arjan Huisman, member of the Management Board and Chief Operating Officer (COO), has indicated that he will not be available for a next term of appointment. Accordingly, he will step down following the Annual General Meeting in May 2026.

Appointed to the Management Board in May 2010, Arjan Huisman is responsible for digitalisation, IT infrastructure, client administration, client monitoring and data management and analytics. He also serves as Chairman of the Supervisory Board of Van Lanschot Kempen Switzerland. During his time at Van Lanschot Kempen, he has rebuilt and professionalised the IT organisation and made an important contribution to the strategic reorientation the company undertook in the past years, including the integration of several acquisitions.
