# Openbaarmaking overeenkomstig de bepalingen van de Wet van 2 mei 2007

13 juni 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE: ANH) ("AB InBev") ("de Vennootschap") kondigt vandaag aan, overeenkomstig artikel 14, eerste lid van de Wet van 2 mei 2007, dat zij twee transparantiekennisgevingen van BlackRock, Inc. heeft ontvangen: één op 10 juni 2025 en één op 12 juni 2025, overeenkomstig de artikelen 6 en 18 van de Wet van 2 mei 2007.

Het percentage van totale stemrechten verbonden aan aandelen gehouden door BlackRock Inc. is eerst onder de drempel van 3% gedaald op 5 juni 2025, als gevolg van de verkoop van stemrechtverlenende effecten of stemrechten in de Vennootschap. Vervolgens heeft het percentage van totale stemrechten verbonden aan aandelen gehouden door BlackRock Inc. op 10 juni 2025 de drempel van 3% overschreden als gevolg van aankopen van stemrechtverlenende effecten of stemrechten in de Vennootschap.
