Disclosure Made According to the Requirements of the Law of 2 May 2007

3 July 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) ("AB InBev") ("the Company") announces today, in accordance with article 14, first paragraph of the Law of 2 May 2007, that it received two transparency notifications from BlackRock, Inc.: one on 1 July 2025 and one on 2 July 2025, in accordance with articles 6 and 18 of the Law of 2 May 2007.

The percentage of total voting rights attached to shares held by BlackRock, Inc. has first crossed downwards the threshold of 3% on 30 June 2025, as a result of disposals of voting securities or voting rights in the Company. Then, the percentage of total voting rights attached to shares held by BlackRock, Inc. has crossed upwards the threshold of 3% on 1 July 2025, as a result of acquisitions of voting securities or voting rights in the Company.
