## Disclosure Made According to the Requirements of the Law of 2 May 2007

13 August 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) (“AB InBev”) (“the Company”) announces today, in accordance with article 14, first paragraph of the Law of 2 May 2007, that it received three transparency notifications from BlackRock, Inc.: one dated 7 August 2025, one dated 8 August 2025 and one dated 12 August 2025, in accordance with articles 6 and 18 of the Law of 2 May 2007.

The percentage of total voting rights held by BlackRock, Inc. has first crossed downwards the threshold of 3% on 6 August 2025, as a result of disposals of voting securities or voting rights in the Company. Then the percentage of total voting rights held by BlackRock, Inc. has crossed upwards the threshold of 3% on 7 August 2025, as a result of acquisitions of voting securities or voting rights in the Company. Finally, on 11 August 2025, the percentage of total voting rights held by BlackRock, Inc. crossed downwards the threshold of 3%, as a result of disposals of voting securities or voting rights in the Company.
