AB InBev reports on the progress of its share buy-back program announced on 30 October 2025

08 Dec 2025 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) (“AB InBev”) (“the Company”) hereby discloses certain information in relation to its share buy-back program announced on 30 October 2025, in accordance with article 8:4 of the Royal Decree of 29 April 2019 implementing the Belgian Code on Companies and Associations. Under this program, AB InBev has granted a discretionary mandate to an independent financial intermediary to repurchase AB InBev shares.

Further to the launch of the share buy-back program announced on 30 October 2025, Anheuser-Busch InBev reports the purchase of 1,155,247 Anheuser-Busch InBev shares in the central order book of Euronext Brussels in the period from 1 December 2025 up to and including 5 December 2025. The shares were repurchased at an average price of 53.1268 EUR per share for a total consideration of 61,374,571.97 EUR.

Since the start of the share buy-back program on 3 November 2025, Anheuser-Busch InBev has bought back 5,262,756 shares for a total amount of 283,931,157.30 EUR (328,571,479.73 USD) under the share buy-back program. This corresponds to 0.26% of the total shares outstanding.
