Disclosure Made According to the Requirements of the Law of 2 May 2007

8 January 2026 – Anheuser-Busch InBev (Euronext: ABI) (NYSE: BUD) (MEXBOL: ANB) (JSE:ANH) (“AB InBev”) (“the Company”) announces today, in accordance with article 14, first paragraph of the Law of 2 May 2007, that it received two transparency notifications from BlackRock, Inc.: one dated 5 January 2026 and one dated 6 January 2026, in accordance with articles 6 and 18 of the Law of 2 May 2007.

The percentage of total voting rights held by BlackRock, Inc. has first crossed upwards the threshold of 3% on 2 January 2026, as a result of acquisitions of voting securities or voting rights in the Company. Then the percentage of total holdings in voting rights has crossed downwards the threshold of 3% on 5 January 2026, as a result of disposals of voting securities or voting rights in the Company.
