# REDEMPTION OF SHARES

The extraordinary shareholders' meeting of Ackermans & van Haaren NV has on 25 November 2011 renewed the powers delegated to the board of directors to redeem shares for a period of 5 years.

In the framework of these powers, Ackermans & van Haaren has concluded a liquidity contract with Kepler Cheuvreux to improve the liquidity of the AvH-share. In the framework of this liquidity programme, Kepler Cheuvreux has in the period from June 9, 2014 until June 14, 2014 acquired a total of 13,600 shares on NYSE Euronext Brussels.

In accordance with the Royal Decree of January 30, 2001, the table below does not provide an overview of any sales of own shares during this period.

Ackermans & van Haaren currently holds 351,218 own shares, i.e. 1.05% of the total shares outstanding.
