# REDEMPTION OF SHARES

The extraordinary shareholders' meeting of Ackermans & van Haaren NV has on 25 November 2011 renewed the powers delegated to the board of directors to redeem shares for a period of 5 years.

In the framework of these powers, Ackermans & van Haaren has concluded a liquidity contract with Kepler Cheuvreux to improve the liquidity of the AvH-share. In the framework of this liquidity programme, Kepler Cheuvreux has in the period from December 8 until December 13, 2014 acquired a total of 8,214 shares on NYSE Euronext Brussels on behalf of AvH.

AvH shares are acquired and sold under this programme. Since 1 January 2014, this has resulted in a net redemption of 7,036 own shares.

In addition, Ackermans & van Haaren acquired 12,250 shares in this period in the context of the stock option plan. Ackermans & van Haaren currently owns 388,500 own shares, or 1.16% of the total shares outstanding, in the context of covering the obligations of the company under the stock option plan.
