ACQUISITION AND DISPOSAL OF OWN SHARES

The extraordinary shareholders' meeting of Ackermans & van Haaren NV has on October 20, 2023 renewed the general authorisation of the board of directors to acquire own shares for a period of 5 years (until October 31, 2028).

This press release includes information on the acquisitions and disposals made between July 23, 2025 and July 31, 2025.

Ackermans & van Haaren NV has concluded a liquidity contract with Kepler Cheuvreux to improve the liquidity of the AvH share. In the framework of this liquidity programme AvH shares are acquired and sold on Euronext Brussels on behalf of Ackermans & van Haaren.

Since January 1, 2025, this has resulted in a net purchase of 13,586 own shares. Kepler Cheuvreux has in the period from July 23, 2025 and July 31, 2025 acquired a total of 20,993 shares and sold 20,383 shares on Euronext Brussels.

Ackermans & van Haaren currently owns 430,485 own shares, or 1.30% of the total shares outstanding.
