# Transparency regulation: Disclosure of a notification received in accordance with the Act of 2 May 2007

In accordance with the requirements of Article 14 of the Act of 2 May 2007 on the disclosure of major shareholdings, Aedifica received on 12 March 2015 a transparency notification from Jubeal Fondation. Jubeal Fondation informed that its shareholding in Aedifica's capital fell below the 5 % threshold as of 4 December 2014.

Aedifica's share capital remains unchanged at €288,276,325.94 and is represented by 10,924,613 shares.
