Ageas reports on the progress of share buy-back programme

Further to the initiation of the share buy-back programme announced on 8 August 2018, Ageas reports the purchase of 83,654 Ageas shares on Euronext Brussels in the period from 27-08-2018 until 31-08-2018.

Since the start of the share buy-back programme on 13 August 2018, Ageas has bought back 413,821 shares for a total amount of EUR 18,487,136. This corresponds to 0.20% of the total shares outstanding.
