## Ageas reports on the progress of share buy-back programme

Further to the initiation of the share buy-back programme announced on 7 August 2019, Ageas reports the purchase of 57,779 Ageas shares on Euronext Brussels in the period from 23-09-2019 until 27-09-2019.

Since the start of the share buy-back programme on 19 August 2019, Ageas has bought back 288,340 shares for a total amount of EUR 14,243,020. This corresponds to 0.15% of the total shares outstanding.
