## Ageas and BlackRock: Transparency notification

In accordance with the rules on financial transparency\*, BlackRock has notified Ageas on 8 June 2020 that, on 5 June 2020, its interest has exceeded the legal threshold of 5% of the shares issued by Ageas. Its current total shareholding stands at 5.77%.
