Update Share Buyback Program (4 November 2014)

In accordance with the regulations Barco NV hereby discloses information regarding the acquisition of own shares.

Under the framework of the share buy-back program, as announced per 7 May 2014, the company reports today that during the period from 27 October 2014 till 31 October 2014 the following transactions took place.
