

## Transparency declaration by BNP Paribas Asset Management Holding: Threshold crossed

**Kortrijk, Belgium, 8 August 2025, 07.00 hrs** – BNP Paribas Asset Management Holding, Paris, France, has notified Barco NV on 5 August 2025 (Euronext: BAR; Reuters: BARBt.BR; Bloomberg: BAR BB) it has crossed the statutory threshold of 3%, holding 2,795,109 shares i.e. 3.01% of Barco's shares and voting rights as of 28 July 2025.
