## **PUBLICATION OF A TRANSPARENCY NOTIFICATION**

## 1. Summary of the notification

Balta Group NV, listed on Euronext Brussels (the "**Company**"), has received on 6 July 2017 a transparency notification dated 6 July 2017. This transparency notification indicates that, on 14 June 2017, Tocqueville Finance S.A., holds 6.64% of the voting rights of the Company. Tocqueville Finance S.A. has therefore crossed the threshold of 5%.

This publication is made by the Company pursuant to the Belgian Law of 2 May 2007 on the disclosure of significant shareholdings in issuers whose shares are admitted to trading on a regulated market.
