Dirk Tirez appointed as CEO bpost group

The bpost Board of Directors has unanimously decided, following the recommendation of bpost's Remuneration and Nomination Committee, to nominate Dirk Tirez as the new CEO of bpost group.

Dirk Tirez is currently Chief Executive Officer a.i. and Chief Legal & Regulatory Officer and Company Secretary.

Dirk was selected from a strong pool of highly qualified candidates following a competitive search and selection process carried out by the Remuneration and Nomination Committee supported by the external executive search firm, Korn Ferry.

Dirk Tirez started his career at the law firm Cleary, Gottlieb, Steen & Hamilton in New York as a member of the New York State Bar and held various positions in private law practice. He was then counsel to the office of the Minister of Finance and was before joining bpost, European general counsel and company secretary of NASDAQ Europe, a subsidiary of The Nasdaq Stock Market, Inc. He joined bpost in 2003 as general counsel (to become later also the company secretary). Dirk Tirez graduated from the Law School at the KU Leuven, the College of Europe in Bruges and obtained, as BAEF-fellow, an LL.M. at the University of Michigan, Ann Arbor. He participated in several executive education programs at the London Business School, INSEAD and the Harvard Business School.
