## **PUBLICATION OF A TRANSPARENCY NOTIFICATION**

On 13 June 2024, Care Property Invest has received a transparency notification dated 7 June 2024.

As a result of an acquisition or disposal of voting securities or voting rights, the overall percentage of voting rights exercisable by Ameriprise Financial Inc. fell below the threshold of 3% on 7 June 2024.

In accordance with Article 18 §1 j° Article 6 §3 of the Law of 2 May 2007 on the disclosure of major shareholdings in issuers whose shares are admitted to trading on a regulated market and containing various provisions, a notification to the issuer and the FSMA is required.

This transparency notification dated 7 June 2024 contains the following information:


