On 12 June 2025, Care Property Invest has received a transparency notification.

As a result of the acquisition of voting securities or voting rights, the overall percentage of voting rights exercisable by BlackRock, Inc. increased above the threshold of 3% on 10 June 2025.

In accordance with Article 18 §1 j° Article 6 §3 of the Law of 2 May 2007 on the disclosure of major shareholdings in issuers whose shares are admitted to trading on a regulated market and containing various provisions, a notification to the issuer and the FSMA is required.

The Company is developing an international portfolio of healthcare projects, which currently counts 151 projects, spread across Belgium, The Netherlands, Spain and Ireland.

The market capitalisation of Care Property Invest amounted to approximately €458 million on 12/06/2025. The Company aims to create a stable share for its shareholders with a low risk profile and a stable and steadily growing dividend.
