On September 20, 2024, EcoR1 Capital LLC had converted 5,873,868 ADRs (as reported in its transparency notification dated September 13, 2024) into ordinary shares. As a result, the number of voting rights linked to voting securities held by EcoR1 Capital LLC crossed the 10% threshold upwards, and the number of voting rights linked to equivalent financial instruments held by EcoR1's Capital LLC crossed the 5% threshold downwards.

Between September 11 and September 20, 2024, EcoR1 Capital LLC further acquired 225,787 ordinary shares and 154,709 ADRs.

Securities reported on the Form are beneficially owned by clients of EcoR1 Capital Fund Qualified LP and EcoR1 Capital Fund LP. Their clients include individuals, endowments, foundations and pooled investment vehicles, etc. EcoR1 Capital Fund Qualified LP and EcoR1 Capital Fund LP are controlled by EcoR1 Capital LLC. EcoR1 Capital LLC is the discretionary investment advisory manager and exercises the voting rights of its entities at its discretion in the absence of specific instructions.
