In anticipation of the announced special powers decree in this respect, the Board of Directors already requests the shareholders to cast their votes in advance by letter, or to grant a power of attorney and, if necessary, to exercise their right to address questions in writing, as explained in the invitation to these General Meetings. The Board of Directors undertakes that the shareholders will only be allowed to participate to the meeting remotely. Questions submitted in writing in advance will be answered via the company's website.
