Report on the progress of the share buy-back programme

Brussels, Belgium – 27 November 2017 – Keyware (EURONEXT Brussels: KEYW) reports on the progress of its share buy-back programme capped to EUR 1 million.

The Extraordinary General shareholders Assembly of Keyware Technologies held on 27 May 2016 has authorized the Board of Directors to launch a share buy-back programme. In May 2017, the Board of Directors has decided to start a share buy-back programme capped to EUR 1 million.

Referring to article 207 of the Royal decree of 30 January 2001 in execution of the Companies code (art. 620 § 1), as modified by Royal Decree of 26 April 2009, Keyware Technologies communicates that it has purchased 13,725 treasury shares at Euronext Brussels in the period between 20 November 2017 and 24 November 2017.

As a result of the purchase transactions up to date and the sale of 47,400 shares on 30 June 2017 in favor of the former shareholders of EasyOrder BVBA, the Company holds a total of 389,818 treasury shares on 24 November 2017 or 1.7870 % of the actual number of shares issued (i.e. 21,813,793).

The share buy-back programme is further executed within the indicated maximum amount of EUR 1,000,000. Under this programme, a total of 425,262 treasury shares have been purchased for an amount of EUR 602,301.02. Hence, the remaining balance is EUR 397,698.98 (which corresponds to approximately 285,294 shares).
