Nyrstar NV announces information on the acquisition of own shares, as required by article 207 of the Royal Decree dated 30 January 2001 executing the Belgian Company Code.

Nyrstar announces today that on 21 and 22 September 2011 it has acquired 249,746 own shares on NYSE Euronext Brussels.

Nyrstar has successfully completed its share buy back program by acquiring an additional 3,500,000 Nyrstar shares during the period from 24 August until 22 September 2011.

The board of director's authorisation to acquire own shares was renewed at the Extraordinary General Meeting dated 26 May 2009.

As announced previously, Nyrstar's ownership of own shares crossed the threshold of 5% of the outstanding shares on 15 September 2011.
