

## Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see press release dated Mar. 1st, 2016), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 29,000 own shares during the period between 04 July 2022 and 08 July 2022 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 48,000 own shares and consequently this results in a net reduction of 19,000 own shares.
