Repurchase of shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 146,585 own shares during the period between 04 May 2026 and 08 May 2026 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 184,627 own shares and consequently this results in a net reduction of 38,042 own shares.
