# Participation notification by KBC Asset Management NV

In accordance with the Act of 2 May 2007 on the publication of important participations in listed companies, Recticel (Euronext: REC) publishes the following notification:

## 1. Summary of notification

Recticel (Euronext: REC) has received a transparency notification dated 24 June 2022, which shows that **KBC Asset Management NV**, as a result of the acquisition of shares on 22 June 2022, **owns 1,662,440 (2.96%) voting rights** (previously 1,648,964 shares or 3.01%) of the company. It has thus crossed downwards the 3% shareholding threshold.

### 2. Content of notification

The notification dated 24 June 2022 contains the following information:

- Reason for the notification: Downward crossing of lowest shareholding threshold. Acquisition or disposal of securities carrying voting rights or voting rights.
