Transparency notification

In accordance with article 14 of the Belgian law of 2 May 2007 on the disclosure of important holdings in issuers whose securities are admitted to trading on a regulated market, Rosier SA (the Company) hereby announces that, following the completion of its capital increase on 29 July 2022² (the Capital Increase), it has received a transparency notification dated 29 October 2022 from Michel Limelette, indicating that as from the Capital Increase, his aggregate holding of voting rights in the Company has fallen below the minimum transparency notification threshold of 2% (the "Notification").

The contents of the Notification are set out below.

Contents of the Notification

- 1) *Reason for the notification:*
 - Passive crossing of a threshold
 - Downward crossing of the lowest threshold
- 2) *Notification by:* A person that notifies alone
- 3) *Persons subject to the notification requirement:* Michel Limelette
- 4) *Date on which the threshold is crossed:* 29 July 2022
- 5) *Threshold that is crossed (in %):* 2%
- 6) *Denominator:* 3,005,000
