January 2013 Update on outstanding securities and voting rights

Mechelen, January 14, 2013 – Telenet Group Holding NV (“Telenet” or “the Company”) (Euronext Brussels: TNET) hereby discloses information in accordance with Article 15 of the Law of May 2, 2007 and the related Royal Decree of February 14, 2008:

Since November 13, 2012, the following movements took place in the share capital and in the number of outstanding voting rights:

- 13,218 Warrants were declared null and void until January 14, 2013.
- On January 8, 2013, 402,018 warrants were converted into 402,018 ordinary shares. As a result thereof, the share capital of the Company was increased with € 43,699.36 and the issue premiums were increased with € 4,619,301.08.

The rights attached to the **Golden Shares** and to the **Liquidation Dispreference Shares** are described in Telenet’s articles of association, available on our website.

Each **Warrant** gives the right to subscribe to one ordinary share under the conditions set out in the terms and conditions of the Stock Option Plan 2007, Stock Option Plan 2008, Stock Option Plan 2009 and Stock Option Plan 2010.

Any increase above (or decrease below) the following thresholds, requires a declaration to Telenet and the Financial Services and Markets Authority (FSMA):

1. 3% statutory threshold, as set out by the articles of association of the Company;
2. 5% or each multiple of 5%, as set out by Belgian law.
