Transparency Declaration

Mechelen, January 14, 2013 – Telenet Group Holding NV (“Telenet” or “the Company”) (Euronext Brussels: TNET) hereby discloses information in accordance with Article 14 of the Law of May 2, 2007 and the related Royal Decree of February 14, 2008:

Today, Telenet received a transparency declaration from Liberty Global, Inc., stating that Liberty Global, Inc. (via its subsidiary Binan Investments B.V.), as of January 8, 2013, holds 56,844,400 shares of the Company, representing 49.95% of the total share capital of the Company on that day, following the issuance of 402,018 new ordinary shares as a result of the exercise of 402,018 warrants.

Any increase above (or decrease below) the following thresholds of total outstanding share capital requires a declaration to Telenet and the Financial Services and Markets Authority (FSMA):

1. 3% threshold, as set out by the articles of association of the Company;
2. 5% or each multiple of 5% threshold, as set out by Belgian law.
