TESSENDERLO GROUP: UPDATE REPURCHASE OF SHARES

With reference to Article 7:215 § 1 of the Companies and Associations Code and Article 8:4 of the Royal Decree of April 29, 2019, implementing the Companies and Associations Code, and as authorized by the Extraordinary General Meeting of Shareholders on May 10, 2022, Tessenderlo Group approved a new share repurchase program on May 12, 2025 for the repurchase of a maximum of 1,050,000 shares of the company for a total amount not exceeding 31,290,000 EUR. Between August 25 and August 29, 2025, Tessenderlo Group acquired 134,900 of its own shares at an average price of 27.07 EUR per share, for a total amount of 3,651,709.82 EUR. As a result of the repurchase transactions, the company holds 540,711 of its own shares in total, or 0.90% of the total number of issued shares as of September 1, 2025.
