

## Transparency notification BlackRock, Inc.

Brussels (Belgium), 8 July 2025 – 20:00 (CEST) – Regulated information

### 1. Summary of the notification

Pursuant to Article 14 of the law of 2 May 2007 on the disclosure of large shareholdings, UCB SA/NV announces that it received a transparency notification from BlackRock, Inc. (having its registered office at 50 Hudson Yards, New York, NY, 10001, U.S.A.), on 4 July 2025.

The notification was made following the acquisition or disposal of the control of an undertaking of the BlackRock group that holds a participating interest in UCB.

On 1 July 2025, BlackRock, Inc. (taking into account the holding of its affiliates) owned 10 848 463 UCB shares with voting rights and 118 231 assimilated financial instruments, representing together 5.64% of the total number of shares issued by the company (194 505 658), versus 5.07% (9 725 971 UCB shares and 126 101 assimilated financial instruments) in the previous notification dated 11 March 2025.

### 2. Content of the notification

- **Reason for the notification:** Acquisition or disposal of the control of an undertaking that holds a participating interest in an issuer.
- **Notification by:** A parent undertaking or a controlling person.
