## All agenda items approved at the Ordinary and Extraordinary General Meeting

On Tuesday 26 April 2011, Umicore held an Ordinary and Extraordinary General Meeting at its headquarters in Brussels, Belgium. Shareholders approved all agenda items. Details of the resolutions are available on Umicore's website.

The Ordinary General Meeting approved the payment of a gross dividend of € 0.80 per new share (ISIN BE0003884047). Taking into account the gross interim dividend of € 0.325 paid in October 2010, a balance gross amount of € 0.475, representing a dividend of € 0.35625 net of withholding tax, will be paid on 4 May 2011. This amount will increase to € 0.40375 in case the new share is matched with the corresponding "VVPR strip".
