On 4 September, UBS AG, located at Bahnhofstrasse 45, 8001 Zurich, Switzerland, has notified the FSMA and Umicore that on 29 August 2014 it has crossed the statutory threshold of 3%, holding 3.38% of Umicore's voting rights.
