Transparency notifications by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BlackRock, Inc. that it has successively crossed the legal threshold of 3% for the direct voting rights downwards on 27 May 2025 and then upwards on 28 May 2025.

The total holding of direct voting rights and equivalent financial instruments of BlackRock, Inc. stands at 4.39% on 28 May 2025.
