Transparency notification by BlackRock, Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by BlackRock, Inc. that it has crossed the legal threshold of 3% for the direct voting rights upwards on 30 June 2025.

The total holding of direct voting rights and equivalent financial instruments of BlackRock, Inc. stands at 4.48% on 30 June 2025.
