Transparency notification by JP Morgan Asset Management Holdings Inc.

In accordance with article 14, § 1 of the law of 2 May 2007 on the disclosure of major holdings, Umicore was recently notified by JP Morgan Asset Management Holdings Inc. that it has crossed the legal threshold of 3% for the direct voting rights upwards on 9 October 2025.

The total holding of direct voting rights and equivalent financial instruments of JP Morgan Asset Management Holdings Inc. stands at 3.43% on 9 October September 2025.
