## UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, June 30<sup>th</sup>, 2025 – Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that in relation to the share buyback program resolved by the Shareholders' Meeting on April 23<sup>rd</sup>, 2025, it has purchased on the Milan Euronext and on multilateral trading facilities, in the period from June 23<sup>rd</sup> to June 30<sup>th</sup>, 2025, a total of 1,180,994 ordinary Amplifon S.p.A. shares, equivalent to 0.522% of the share capital, at an average unit price of Euro 19.978 per share, for a total consideration of Euro 23,593,379.50.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on daily basis:
