Digiproces is recognized for its advanced electronic manufacturing capabilities and for a strong commitment to the digitalization of industrial processes, positioning it as a complementary partner to FAE Technology's design, development and digital innovation competences.

The dedicated digital platform enables the seamless integration of hardware and software development processes, supporting the creation of complex prototypes while ensuring high standards of efficiency, traceability and quality. The solution provides advanced configuration and component-selection tools and delivers online quotations rapidly, streamlining the entire prototyping workflow and significantly reducing turnaround times. Designed to meet customers' testing requirements, the platform incorporates certified quality processes and guarantees fully "EU-manufactured" output, strengthening compliance and supply-chain reliability. These features offer tangible evidence of FAE Technology's ability to combine vertical engineering expertise and industrial assets with advanced digital capabilities, laying the foundations for a collaborative ecosystem capable of responding flexibly to evolving market demand.

The Group, through several dedicated and integrated assets, can very rapidly enable electronic innovation in the various sectors in which it plays a central role, including e-mobility, the Internet of things (IoT), industrial automation 4.0 and aerospace.
