# DOVALUE: REGISTRATION OF THE OF DEED OF MERGER BY INCORPORATION OF GARDANT S.P.A. AND SPECIAL GARDANT S.P.A. IN DOVALUE S.P.A.

**Rome, December 15**<sup>th</sup>, **2025** – Following what has already been communicated to the market, we inform that today the deed of merger by incorporation of the subsidiaries Gardant S.p.A. and Special Gardant S.p.A. in doValue S.p.A. executed on last 10 December has been registered at the competent Companies Registers, whose merger plan has been approved by the relevant Boards of Directors on 25 September for doValue S.p.A., and 29 September for Gardant S.p.A. and Special Gardant S.p.A..

Due to the merger, starting from 1 January 2026 the incorporating company doValue S.p.A. succeeds into all the rights and obligations headed by Gardant S.p.A. and Special Gardant S.p.A.. The accounting and tax effects also take effect from January 1, 2026.

Additional shares by reason of merger will not be issued, since doValue owns the entire share capital of the Company to be Incorporated.

The deed of merger is made available to the public – pursuant to the applicable laws – at the company's registered office as well as on the authorized storage mechanism eMarket Storage and is also available to the consultation on the website <a href="https://www.dovalue.it">www.dovalue.it</a>.
